## Latest figures published

We have published our latest quarterly figures (1 October to 31 December 2013) on the development of the Non-Domestic RHI.

- We received 788 new applications – a 16% decrease from the number of applications received in the previous quarter (938).
- We accredited 537 installations – a 21% decrease

from the previous quarter (678).

- Renewable heat generated was 99 GWh, bringing the amount of heat generated to 643 GWh since the scheme started.
- We made £7.8m in scheme payments – a 13% increase on the payments made in the previous quarter (£6.9m).
- The RHI enquiry line received an average of 4,622 enquiries (phone calls and emails) a month – a 13% increase on the previous quarter.

These figures show that we received fewer applications, with an overall decrease in accredited installations since our quarterly report for [July to September 2013](#). This is partly attributable to the need to amend the Non-Domestic RHI Regulations, which meant many applications had to be put on hold. The amendments came into force on 13 December 2013.

We are now processing all affected cases and continue to assist applicants with any queries they may have about their submissions.
