Where properties are privately rented - LANDLORD PERMISSION DECLARATION: I can confirm I am the landlord/management company of the below property/properties and hereby give my consent for the works as indicated below to be completed. I understand I may be contacted by any organisation carrying out the installation works or providing the funding, Ofgem or an energy supplier to verify this letter of permission. By signing this letter, I acknowledge that funding is being claimed through the Energy Company Obligation (ECO3) scheme and I will not seek any funding through the domestic renewable heat incentive [see article 19(1)(d) of the ECO3 Order].

## For loft insulation measures:

I confirm that if a loft insulation measure is being installed, no loft insulation was removed from the loft within the past six months (if both tenancy and ownership has changed within this time period, since commencement of tenancy and ownership) or has previously been claimed under ECO.

First Time Central Heating (FTCH) only: I, the owner of the premises, declare that to the best of my knowledge, at no point prior to the installation of the first time central heating, first time district heating system or first time renewable heating system, did the premises have a central heating system, district heating system, or renewable heating system nor, immediately prior to the installation, did the premises have a working, efficient electric storage heater(s)2.

- 2. All FTCH measures must meet both the roof, and cavity wall insulation pre-conditions to be eligible measures. The pre-conditions require that the total roof area, and any exterior facing cavity walls of a property are insulated prior to the installation of a FTCH measure.
- 3. The signatory must review the available evidence and records relating to the premises prior to signing this declaration. The presence of a central heating system (including district and renewable heating) or a working, efficient electric storage heater can be identified with reference to any available evidence within or records relating to the premises. Examples could include an old boiler, pipework, heating controls, radiators, storage heaters or documents such as an EPC. Where such evidence exists, the measure would be ineligible under this provision.
