Notice of statutory consultation on a proposal to modify the Special Conditions and the Standard Special Conditions of the Gas Transporter licence held by licensees listed above

- 1. The Gas and Electricity Markets Authority ('the Authority')¹ proposes to modify the Special Conditions and Standard Special Conditions (SSCs) of the Gas Transporter licence held by each of the above licensees ('the licensees') granted or treated as granted under section 7 of the Gas Act 1986 by:
 - a. Amending the existing Special Conditions, including the Price Control Financial Handbook;
 - b. Amending the existing SSCs; and
 - c. Issuing the NARM Handbook and Network Asset Risk Workbook, which form part of Special Condition 3.1 (Baseline Network Risk Output).
- 1. The reasons and effects of these proposed modifications together with the full text of the proposed modifications can be found on our website², alternatively they are available from foi@ofgem.gov.uk. Modifications that were substituted by the CMA's Order³ on RIIO-2 Appeals⁴ are shown in green highlight.
- 2. In addition, further details and background on these proposed changes are set out in the following documents:

 - b. Ofgem's Consultation on Licence fee cost recovery principles⁵.
