Electricity Act 1989
Notice of Proposal to revoke a Final Order
Made under section 25(1) of the Electricity Act 1989 ("EA89")

Proposal of the Gas and Electricity Markets Authority ("the Authority") to revoke a Final Order ("FO") pursuant to section 26(6) of the Electricity Act 1989 ("EA89").

1. Background

- 1.1. Delta Gas & Power Limited (company number 09933244) ("Delta") whose registered office is situated at 344-354 Gray's Inn Road, London, England, WC1X 8BP is the holder of an electricity supply licence issued by the Authority under section 6(1)(d) of the Electricity Act 1989 ("Act").
- 1.2. After consultation, the Authority issued a Final Order dated 27 September 2022 ("the Final Order") to Delta. A copy of the Final Order can be found on the Authority's [website](#)
- 1.3. The Final Order required Delta to discharge its Renewables Obligation (RO) and Renewables Obligation Scotland (ROS) obligations by 31st October 2022.

2. Reasons for the Authority's Decision to propose to revoke the Final Order

- 2.1. For the reasons set out below, the Authority now proposes to revoke the Final Order:
 - 2.1.1. On 25 November 2022, Delta paid the outstanding funds relating to their Renewables Obligations for the relevant year.
- 2.2. The Authority is satisfied that the Final Order is no longer requisite for the purposes of bringing Delta into compliance with article 7 of the Renewables Obligation Order 2015 ("ROO") and article 5 of the Renewables Obligation (Scotland) Order 2009 ("ROS").

2.3. Accordingly, the Authority hereby gives notice under sections 26(6) of the EA89 and section 29(5) of the GA86 that it proposes to revoke the Final Order.

2.4. The Authority reserves its position with regard to any further enforcement action it may decide to take in connection with this matter

3. Representations or Objections

3.1. The Authority invites representations or objections in relation to its proposal to revoke the Final Order.

3.2. Any representations or objections in respect of this notice of the Authority's proposal to revoke the Final Order must be made in writing on or before 5pm on 19 January 2023 (being not less than 28 days from the date of the publication of this notice) by email to tom.sykes@ofgem.gov.uk and jonathan.mcleod @ofgem.gov.uk.

3.3. Responses will normally be published on the Ofgem website. Should you wish your response or part of your response to be confidential please indicate this clearly and give reasons for your request. Any such requests will be considered by Ofgem on a case-by-case basis.

3.4. Any representations or objections, which are duly made within the timeframe specified above and not withdrawn, will be considered by the Authority.
