Notice of statutory consultation on a proposal to modify the Special Conditions of the electricity distribution licence held by each of the above licensees

- The Gas and Electricity Markets Authority ('the Authority')¹ proposes to modify the electricity distribution licence held by each of the above licensees ("the licensees"), granted or treated as granted under 6(1)(c) of the Electricity Act 1989 by:
 a. removing the existing Special Conditions; and
 - b. inserting new Special Conditions, including the following licence instruments:
 - i. the ED2 Price Control Financial Model;
 - ii. the ED2 Price Control Financial Handbook;
 - iii. the Network Asset Risk Workbook; and
 - iv. the Load Related Expenditure Volume Drivers Governance Document.

¹ The terms "the Authority", "we" and "us" are used interchangeably in this document.

- We are proposing these modifications to give effect to our RIIO-ED2 Final Determinations for electricity distribution companies. The proposals also aim to improve the clarity of the licence and its relationship with the Price Control Financial Instruments established by the licence.
