Electricity Act 1989 Section 11A(2)

Notice of statutory consultation on a proposal to modify the Standard Conditions of all electricity distribution licences

- The Gas and Electricity Markets Authority ('the Authority')¹ proposes to modify the Standard Conditions of the electricity distribution licence held by each of the above licensees ('the licensees') granted or treated as granted under 6(1)(c) of the Electricity Act 1989 by:
 - a. amending the Standard Conditions set out in Annex 1;
 - b. inserting new Standard Conditions set out in Annex 2; and
 - c. removing existing Standard Conditions set out in Annex 3.
- We are proposing these modifications to give effect to our RIIO-2 Final Determinations for electricity distribution companies. The proposals also aim to improve the clarity of the licence.
