





Meet the Owners




- The Project is being delivered by a consortium led by Ocean Winds (95%) together with minority partner Ignitis (5%).
- Ocean Winds is a 50:50 joint venture by ENGIE and EDP dedicated to offshore wind.
- Sponsors are members of world leading renewable utilities and have proven experience in development, construction, operation and maintenance of first class assets.
- Ocean Winds' offshore wind gross capacity already operating, under construction or in advanced development reaches 16.6 GW globally. In Scotland, OW is the second largest developer with a gross capacity of 6.1 GW.
- OW is also the majority shareholder of Moray East, Scotland's largest operational offshore wind farm.






- 60 SGRE DD-222x14.7MW turbines
- A network of 66kV inter array cables connecting in a radial configuration with 5 WTGs per string
- Grid entry point is at 66kV busduct terminations installed at the 66kV incomer circuit breaker
- 2 OSPs are connected via one 66KV interlink cable that shall be retained by the developer
- The power is transmitted from two OSPs to the transition joint bay via 2 circuits of offshore export cable

- 2 circuits of onshore export cable connected to onshore substation
- Transmission interface point is at SHET Blackhillock 400kV substation


