

## Energy companies' Consolidated Segmental Statements

Following our 2008 Energy Supply Probe we introduced the Financial Information Reporting licence condition, which came into force in 2009. It aims to increase transparency of energy companies' revenues, costs and profits by requiring the large vertically integrated energy companies to produce and publish Consolidated Segmental Statements (CSS). The CSS are annual statements segmenting the financial results of their supply and generation activities.

Companies must publish their CSS on their website. You can access each company's CSS following the links in the table below. More information on past years' CSS is available on Ofgem's website.
