## Electricity Act 1989 Section 11A(2)

## Notice of statutory consultation on a proposal to modify the Special Conditions of the electricity transmission licence held by National Grid Electricity System Operator Limited

- 1. The Gas and Electricity Markets Authority ("the Authority")¹ proposes to modify the electricity transmission licence held by National Grid Electricity System Operator Limited ("the licensee"), granted or treated as granted under section 6(1)(b) of the Electricity Act 1989 by amending Special Condition 1.1 ('SpC 1.1'), Special Condition 2.12 ('SpC 2.12'), Special Condition 4.2 ('SpC 4.2'), Special Condition 4.7 ('SpC 4.7'), Special Condition 5.1 ('SpC 5.1') and Special Condition 5.2 ('SpC 5.2'). We further propose housekeeping amendments to Chapter 1.
- 2. We are proposing these modifications to implement our RIIO-2 Business Plan 2 (BP2) Final Determinations<sup>2</sup> and improve the clarity of the licence and its relationship with the Price Control Financial Instruments (PCFIs) established by the licence, for both the ESO Price Control Financial Model (PCFM) and the ESO Price Control Financial Handbook (PCFH) following our PCFM Working Groups earlier in the year.
- 3. The reasons and effects of the proposed modifications, together with the full text of the proposed modifications, are published alongside this notice on our website (<a href="www.ofgem.gov.uk">www.ofgem.gov.uk</a>), alternatively they are available from <a href="mainton.rights@ofgem.gov.uk">information.rights@ofgem.gov.uk</a>. In addition, further details and background on some of these proposed changes are set out in our BP2 Final Determinations.
