## **Statutory Consultation: Smart Meter Reporting Requirements**

Thank you for the opportunity to respond to the proposed changes to the smart meter reporting requirements for 2024 and 2025.

E.ON's response to this consultation is not confidential and so we are happy for this response to be published in whole or in part, alongside those of other energy suppliers. E.ON notes that the changes within this consultation are limited in scope to the licence conditions changes necessary to improve reporting requirements and we have responded to each question accordingly.
