## Direction under Part B of Special Condition 9.20 (Tender Support Activities in Onshore Electricity Transmission) to issue the Onshore Competition Information Exchange Guidance

- 1. Each of the licensees to whom this document is addressed is the holder of an Electricity Transmission licence ('the Licence') granted or treated as granted under section 6(1)(b) of the Electricity Act 1989 ('the Act').
- 2. On 10 December 2024 the Gas and Electricity Markets Authority ("the Authority")<sup>1</sup> published on its website the text of the proposed Onshore Competition Information Exchange Guidance and stated that representations must be made on or before 13 January 2025.
- 3. We received 4 representations, which we have carefully considered. We have placed all non-confidential representations on our website. Our response to these representations is set out in our Decision on Modifications to the special licence conditions in the electricity transmission licences: Early Competition in Onshore Electricity Transmission is published alongside this document or can be found on our website at <a href="https://www.ofgem.gov.uk">www.ofgem.gov.uk</a>.
- 4. We have made a number of changes to the proposed text as a result of representations and have also made some typographical changes, where necessary, to improve drafting. The full text of the Onshore Competition Information Exchange Guidance as well as the tracked changes version compared with the version published on 10 December 2024 is published alongside this document or can be found on our website at <a href="https://www.ofgem.gov.uk">www.ofgem.gov.uk</a>.
- 5. The reason for this direction is to give effect to our Decision to have an Onshore Competition Information Exchange Guidance which provides further detail on the licensees' obligations when conducting Tender Support Activities in onshore electricity transmission as well as the Delivery Body's role in requesting, processing, and sharing information.
