

## To: National Gas Transmission Plc ('NGT')

6 June 2025

Direction issued by the Gas and Electricity Markets Authority ("the Authority") under Special Condition ("SpC") 3.14.4 and 3.14.9 of the Gas Transporter Licence ("the Licence") held by National Gas Transmission plc to modify the value of licence terms NARMAHOt NLAHOt and AHt, as well as the outputs, delivery dates and allowances in the Asset health Non-Lead Assets PCD tables.

- 1. The licensee is the holder of a Licence granted or treated as granted under section 7 of the Gas Act 1986.
- 2. SpC 3.14.4 (Asset health Re-opener AHt) of the Licence provides a mechanism, by which the Licensee may apply for a direction.
  - a) adjusting the value of the AHt term.
  - b) adjusting the value of the NARMAHO<sub>t</sub> term
  - c) adjusting the value of the NLAHOt term; or
  - d) amending the outputs, delivery dates and allowances in the Asset Health Non-Lead Assets PCD Tables

where it is seeking allowances for work relating to Valves, Compressor Cabs or Plant and Equipment during the period between 1 April 2023 and 31 March 2026.

- 3. SpC 3.14.9 (Asset health Re-opener AHt) of the Licence provides a mechanism, by which the Authority may direct.
  - a) An adjustment to the value of the AH<sub>t</sub> term.
  - b) An adjustment to the value of the NARMAHOt term
  - c) An adjustment to the value of the NLAHOt term
  - d) An adjustment to the outputs, delivery dates and allowances in the Asset Health Non-Lead Assets PCD Tables

to reflect actual efficient costs and work volumes relating to Valves, Compressor Cabs or Plant and Equipment during the period between 1 April 2021 and 31 March 2024.

**4.** On 31 January 2024, the Licensee submitted Asset health Re-opener applications under SpC 3.14.4 and 3.14.9, which complied with the requirements of SpC 9.4 Re-opener Guidance and Application Requirements Document.

## Asset health Re-opener Direction

- 5. The Authority hereby issues a direction under SpC 3.14.4 and 3.14.9 to:
  - a) An adjustment to the value of  $AH_t$  as specified in Table 1 in paragraph 7.
  - b) An adjustment to the value of NARMAHO $_{\rm t}$  as specified in Table 1 in paragraph 7.
  - c) An adjustment to the value of NLAHOt as specified in Table 1 in paragraph 7.
  - d) Modify the outputs, delivery dates and allowances in the Asset Health Non-Lead Assets PCD Tables in the manner set out in Asset health Re-opener Applications Submitted by National Gas Transmission (January 2024); and
  - e) An amendment to the text in Appendix 2 to SpC 3.15 as provided for in paragraph 8.
- 6. Further details of the reasons for and effect of this direction and the modifications listed in paragraph 5 can be found in our decision document published alongside this direction on 6 June 2025.
- 7. This direction will amend the value of the relevant licence terms as set out in Table 1 below.
