Energy Code Reform: Membership of the Implementation Workgroups (Phase 1)

We would like to thank stakeholders who responded to our request for volunteers to join Ofgem's Implementation Workgroups (Phase 1) (IWP1s). To provide visibility to stakeholders, this letter confirms the membership of the IWP1s.

Context

Alongside our April 2025 consultation on the implementation of energy code reform, we published a request for volunteers to join Ofgem-led workgroups. The purpose of the IWP1s is to support Ofgem in the development of the modification proposals which we expect to consult on as part of our work to implement energy code reform.

In the Expressions of Interest we stated that we intended to keep the agenda of each session as focused as possible, to minimise the burden on attendees, by dividing discussion on relevant topics between three separate workgroups:

- a Balancing and Settlement Code (BSC) workgroup
- a Retail Energy Code (REC) workgroup, and
- a cross-cutting workgroup, to address policy and planning topics that may have an impact on a broader range of energy codes (eg, the introduction of a harmonised modification of process).

We are grateful to respondents who offered their time to participate in the IWP1s. In our request for volunteers, we stated that we wanted to encourage as much involvement as

possible from stakeholders with relevant expertise, with any interested party invited to attend. We stated that we were seeking members who:

- have BSC or REC expertise
- have cross-code expertise
- can provide multiple constituency or industry perspectives
- are, or were previously, a member of a code panel, and
- · have broad relevant skills and knowledge.

Although we did not place a formal cap on the number of potential attendees, we did advise that we may take steps to limit numbers for individual workgroup sessions where needed. We assessed the responses against these considerations, and it was deemed unnecessary to limit numbers for individual workgroup sessions.

We will therefore convene 3 different workgroups: (1) IWP1 BSC; (2) IWP1 REC; and (3) IWP1 Crosscutting. We have set out below the members for each of the IWP1s.
