GEMA Minutes for 08 July

4. Heat Network Penalty Policy and Enforcement Decision Delegation

The Board noted that the Heat Networks (Market Framework) (Great Britian) Regulations 2025 would come into force on 27 January 2026. In respect of establishing the framework for Heat Networks enforcement, the Board approved the draft Penalty Policy for consultation, and approved updates to be made to the Terms of Reference for the Enforcement Decision Panel (EDP) and Settlement Committee, and delegated authority for certain enforcement decisions.

5. Annual Report and Accounts 2024-25

The Board noted the update on the Annual Report and Accounts which was scheduled to be and laid in Parliament the following week. The Board delegated final approval of the 2024-25 Annual Report and Accounts to the Audit and Risk Assurance Committee.

6. GEMA Rules of Procedure review

The Board noted the recommendations of the review of GEMA's Rules of Procedure and approved the proposed housekeeping updates.
