This version reflects changes to scheme policy signalled in the government response to the Expanding the Warm Home Discount Scheme, 2025 to 2026 consultation, and made by the Warm Home Discount (Amendment) Regulations 2025. We have also made general formatting and drafting improvements.

### Removal of high energy cost threshold for Core Group 2 in SY15

- New sentence in 'About this guidance' references the removal of the high energy cost threshold for Core Group 2 in SY15.
- Text and footnote in chapter 1 (paragraph 1.14) references the removal of the high energy cost threshold in SY15.
- New sentences (paragraphs 2.6, 2.8) reference the removal of the high energy cost threshold in SY15.
- Edited text and new sentences in chapter 4 (paragraphs 4.3, 4.31-4.32, 4.36, 4.43) clarify that in SY15, the high energy cost threshold is removed.

### Extension of rebate notice period in SY15

 New sentence in chapter 5 (paragraph 5.3) references the extension of rebate notice period in SY15 from 1 March 2026 to 31 March 2026.
