These updates clarify the circumstances when we will seek to reject non-compliant measures. The new version contains general formatting and drafting improvements as well as specific updates described below.

TrustMark Non-compliance

Added new wording in paragraphs 7.35-7.36 clarifying that Ofgem will refer measures to rejections when the TrustMark certificate of lodgement has been voided, and describing how supplier representations will be handled in such cases.

Removal of references to monitoring guidance throughout.

Disclaimer

Update of the legal disclaimer on page 8 to clarify the purpose and limits of the guidance.

Personal data

Paragraph 1.17: New section on processing of personal data by Ofgem.

Signposting

Paragraph 1.18 to 1.23: New paragraphs and amendments to more accurately signpost suppliers towards stakeholders for specific queries. New detail on submitting compliance process queries.

References to government

Out of date references throughout the document to the Department for Business, Energy, and Industrial Strategy have been replaced with signposting to the Department for Energy Security and Net Zero.

Rejections

Paragraph 7.38: New paragraph noting that where measures are rejected for administrative reasons, suppliers should notify (or re-notify) the completed *project* with the 'Rejection adjusted finishing SAP rating' field completed.

Paragraph 7.39: Additional paragraph to clarify that where retrofit assessments are redone, the appropriate version of RdSAP should be used.

Trustmark certificate of lodgements

Paragraph 7.48: New paragraph to clarify that in circumstances where non-compliance with any of the TrustMark requirements is detected, measures may be rejected.

ECO privacy notice

Paragraph 7.107: Replacing reference to the ECO4 working group privacy notice with Ofgem's ECO privacy notice, as the latter is endorsed by Ofgem and so is more appropriate for suppliers to provide to occupants or landlords.

Inter-supplier transfers

Paragraph 8.10: Addition to clarify that measures with withdrawn status are also eligible for transfer.

Reassigning ECO4 delivery towards GBIS

New chapter 9 on how suppliers can reassign annual bill savings from ECO4 to their GBIS obligation and additional references to this new mechanism and chapter throughout the document.
