Erratum Notice - RIIO-2 Re-opener SAR Final Modification Notice

In November 2025, we¹ published our Modification of the special conditions of the electricity distribution licence² held by all Electricity Distribution to implement our decisions on efficient cost allowances for re-opener applications submitted in January 2024. These modifications introduce Price Control Deliverables (PCDs) for projects funded under the Storm Arwen Re-opener, ensuring companies deliver agreed outputs or return funds to consumers.

It has come to our attention, however, that there are a number of minor errors contained in some of the published Modification of the special conditions of the electricity distribution licence. It is therefore necessary to consolidate all the necessary changes as part of this housekeeping amendments to the relevant documents.

We have identified and addressed several issues in the Storm Arwen Re-opener modification notice, the details of which are set out in **Appendix 1**.

Attached to this letter in **Appendix 1**, is an error log setting out the identified errors and the amendments we made to correct them. Alongside this erratum notice, we have republished the relevant 'revised' decision to modify the special conditions of the electricity distribution licence.
