Notice of statutory consultation on a proposal to modify the Special Conditions 3.13 of electricity transmission licence held by Scottish Hydro Electric Transmission plc ('SHET') to enable the addition of funding related to the Gremista Grid Supply Point ('Gremista GSP') Project

1. The Gas and Electricity Markets Authority ('the Authority') proposes to modify the Special Condition ('SpC') 3.13 (Large Onshore Transmission Investment Re-opener (LOTIREt)) of the electricity transmission licence ('the Licence') held by SHET, granted or treated as granted under 6(1)(b) of the Electricity Act 1989 by amending SpC 3.13 (Large Onshore Transmission Investment Re-opener (LOTIREt)).
2. We are proposing these modifications to the Licence because adding LOTI Outputs into Appendix 2 of SpC 3.13 gives effect to the decision of the Authority dated 12 December 2025 to approve funding for SHET's Gremista GSP project.
3. The effect of the proposed modifications is to enable SHET to access funding to deliver the Gremista GSP project. Further details on the reasons for the proposed modifications can be found in our [RIIO-2 Re-opener Applications 2025: Electricity Transmission, Electricity Distribution and Gas Distribution | Ofgem](#) documents available on our website.
