1. ECO4 Delivery Guidance

Version 4.0

These updates reflect the extension of ECO4 by nine months to 31 December 2026. The new version also contains general formatting and drafting improvements.

General

Changes to this document have been made to reflect the changes to the ECO Order 2022 on extending the end date of ECO4 by nine months to 31 December 2026.

Occupancy

Paragraph 3.54: New wording to confirm that a 'matched' DWP reference is evidence of eligibility for the scheme and is not on its own sufficient evidence to prove that someone *occupies* a premises.

Evidencing Eligibility

Removal of Working Tax Credit (WTC) and Child Tax Credit (CTC) in Table 2, which ended in April 2025. This change is also reflected in 10.47 and 10.61. Paragraph 10.50 has also been deleted. The sample letters for Working Tax Credit (Example 3 pg. 216) and Child Tax Credit (Example 4, pg. 218) have been deleted.

Paragraph 3.134: Clarification added that Working Tax Credit and Child Tax Credit ceased to exist on 5 April 2025. Due to the 12-month rule, receipt of WTC or CTC will remain legitimate evidence until 4 April 2026.

Paragraph 3.158: Removal of reference to Tax Credit on Income Levels under Child Benefit.

ECO4 Flex Statement of Intent (SoI)

Paragraph 3.177: A new addition added to clarify that the Great British Insulation Scheme closed on 31 March 2026. In addition, LAs do not need to publish a new SoI just to remove references to GBIS, but any LAs who onboard after this date can use the updated SoI template which references ECO4 only.

Interaction With Funding from Other Schemes

Paragraph 4.93: Footnote added referencing the government response 'Amending the ECO4 Order to allow cost recovery via grant funding'. The full list of named additional schemes from which funding cannot be blended has been included.

Identification Of the Pre-Main Heat Source for Heating Measures – Proxies

These updates reflect changes made by part 10 of The Electricity and Gas (Energy Company Obligation) Order 2023, which applies to measures installed from 14 August 2023. The new version contains general formatting and drafting improvements as well as specific updates described below.

Renewable heating systems

The definition of renewable heating system now allows for heating systems to be partly fuelled by a renewable source of energy or technology. This enables solar PV alongside electric heating and some hybrid heat pump systems (excluding coal, oil and LPG) to be installed as ECO4 measures.

Solar PV

Solar PV may be installed in both on-gas and off-gas homes that either already have a hydronic heat pump, electric storage heater (ESH), or an electric heating system (EHS). If the home has none of these measures, one must be installed as part of the ECO4 project. This still applies in scenarios where one of these measures is to be installed alongside solar PV. Installation of solar PV alongside such ESH or EHS will be allowed as a separate installation or as part of an ECO4 project.

ESH/ESH

An ESH or EHS measure may be installed to off-gas premises where:

- it replaces an existing EHS,
- one or more ESH is already installed, and
- the premises has neither an efficient nor inefficient heating system

Off-gas homes & DHS

As is already the case for on-gas homes, off-gas homes are able to connect to district heating systems fuelled wholly or partly by gas. An off-gas home that receives a connection to a gas fuelled DHS will still be considered an off gas home post installation.

Signatures

Version 2.0 also reflects that signatures are no longer required on local authority declaration forms, and introduces an example scenario of notifying projects with smart thermostat measures.

Eligibility requirements for Solar PV corrected for social housing SAP band D by adding in the requirement described in Number 4 of the Key.

Clarity of room-in-roof insulation description improved for cases where the residual area is or is not insulated.

Improved clarity to Footnote 4 in the key, by adding "heating" to "...innovation heating measure" for the avoidance of doubt.

New sub-row added within District Heating Connection (DHC), which refers to DHC using shared ground loops (SGL) only. Eligibility tick also added to show that if installed in social housing SAP Band D, then it needs to be an innovation measure (IM). For all other tenure types, it does not need to be an IM.
