## <u>GB Consultation for Scottish Grid Code Change Proposal SA2004 (Consultation on Technical Requirements for Windfarms)</u>

Ofgem/DTI's May 2004 consultation on the Grid Code under BETTA described the procedure that Ofgem would follow when consulting on a Great Britain (GB) wide basis for change proposals to the Scottish Grid Code that are under consideration. Ofgem considers that it is generally appropriate to consult on Grid Code change proposals on a GB wide basis following the Second Reading of the Energy Bill which introduces the British Electricity Trading and Transmission Arrangements (BETTA). The Energy Bill received its second reading on 11 December 2003.<sup>1</sup> Ofgem considers that it is appropriate to invite responses on any additional implications that Scottish Grid Code Change Proposal SA/2004 (Consultation on Technical Requirements for Windfarms) may have, were it to be applied on a GB wide basis, as opposed to being limited to Scotland.
