GAS TRANSPORTERS LICENCE

Direction issued by the Gas and Electricity Markets Authority

WHEREAS:

- (a). Transco plc ("Transco"), a company registered in England and Wales with company number 2006000 and registered office at 1-3 Strand, London WC2N 5EH is the holder of a gas transporters licence treated as granted by the Gas and Electricity Markets Authority ("the Authority") under section 7 of the Gas Act 1986 ("the Act") which was amended and restated by a licensing scheme made by the Secretary of State for Trade and Industry (the "Secretary of State") pursuant to paragraph 19 of Schedule 7 to the Utilities Act 2000 on 28 September 2001 ("the original licence").
- (b). Until 1 February 2001, the original licence related to both Transco's National Transmission System ("NTS") and eight Distribution Networks ("DNs").
- (c). Transco is proposing to hive down four of its DNs into four wholly owned Transco subsidiary companies, the shares in which would then be sold to third party purchasers (the "Proposed Transaction"). As part of this process, the original licence is to be to be substantially modified and restructured so that it refers to the NTS only. The four DNs to be sold will be held under four separate gas transporters licences (the "IDN licences") and the remaining four DNs will continue to be owned by Transco but will be held under a separate gas transporter's licence (the "RDN licence"). On 5 November 2004, Transco was granted five additional licences (the "additional licences") in substantially the same form as the original licence in connection with the Proposed Transaction. It is proposed that four of these additional licences will be transferred to the four relevant wholly owned subsidiary companies.

- (d). Pursuant to Amended Standard Condition 29 of the original licence, the Proposed Transaction requires the consent of the Authority and the Secretary of State. On 20 January 2005, the Authority met at a duly convened Authority meeting to consider Transco's applications for such consent. After careful consideration, the Authority granted four conditional consents ("the consents") to Transco under Amended Standard Condition 29 of the original licence to dispose of each the four relevant DNs from Transco to four relevant wholly owned subsidiary companies. Such disposal is not permitted to take place prior to 1 May 2005. As the Authority's consents were granted on a conditional basis¹, Transco is required to satisfy a number of conditions precedent before the consents become effective. In addition, the Authority also attached a number of conditions subsequent to its consent. In particular, and without limitation, the Authority's further consent is required in relation to a number of areas of the Proposed Transaction. For example, Transco is prohibited from disposing or relinquishing control (directly or indirectly) of the shares in the four relevant wholly owned subsidiary companies without the prior written consent of the Authority.
- (e). Further to the consents, on 1 February 2005, in accordance with the powers contained in section 23 of the Act and with the written consent of Transco the Authority issued a direction modifying the original licence, the RDN licence and the IDN licences to achieve revenue separation between the original licence, the RDN licence and the IDN licences. However, each of the original licence, the RDN licence and the IDN licences continued to be owned and held by Transco.
- (f). Pursuant to section 8AA of the Act, the transfer of a licence also requires the consent of the Authority. As part of the Proposed Transaction, Transco proposed that at hive down, each of the IDN licences be transferred to the relevant wholly owned Transco subsidiary company. On 25 April 2005, the Authority met at a duly convened Authority meeting to consider the Transco's applications for such consent. After careful consideration, the Authority granted conditional consent to the transfer of the four IDN licences. Such consents became effective today following satisfaction of the relevant conditions.

- (g). Also today the Authority issued a direction to implement the modifications to the original licence and the RDN licence pursuant to section 23. In addition, the Authority today issued a direction pursuant to section 8AA of the Act to implement the modifications to the four IDN licences. Such modifications to the IDN licences were a condition to the Authority's consent under section 8AA to transfer the IDN licences.
- (h). Transco currently holds a number of consents, acceptances, approvals, directions, indications, agreements and other similar licence related instruments ("LRIs") in relation to the original licence (the "existing LRIs"). The existing LRIs relate to both the NTS and the DNs.
- (i). Pursuant to a letter issued by the Authority on 19 October 2004 (the "comfort letter"), the five additional licences have the benefit of the existing LRIs until the date of hive down.
- (j). At hive down, due to the scale of the restructuring of the two licences which will be retained by Transco (i.e. the original licence in respect of the NTS and the RDN licence in respect of the RDNs) and the four licences that will be transferred to the four wholly owned Transco subsidiary companies (i.e the IDN licences) and the expiry of the comfort letter (referred to above):
 - i. the existing LRIs will not necessarily continue to apply to the original licence (as it will relate to the NTS only);
 - some of the existing LRIs relating to the NTS will need to be restated so as to make reference to the correct licence condition numbers in original licence (as restructured);
 - iii. none of the existing LRIs will apply in respect of either the RDN licence (that will be held by Transco) or the four IDN licences (that will be transferred to the four wholly owned Transco subsidiary companies); and
 - iv. certain new additional LRIs will be required in respect of both the original licence (in respect of the NTS), the RDN licence and the four IDN licences.
- (k). On 28 April 2005 Transco wrote to the Authority (both for itself and on behalf of its four relevant wholly owned subsidiary companies providing a list (as amended by subsequent correspondence) of the existing LRIs it considered would be relevant following completion of the Proposed Transaction and in relation to which licences and licence conditions such LRIs would apply. Transco confirmed that those existing LRIs not included on the list would no longer be required once hive down had occurred. The list also set out new LRIs which Transco considered would be necessary for the NTS and / or DNs following completion of the Proposed Transaction.

- (l). Against this background, Transco requested that:
 - I.1 certain of the existing LRIs be amended and restated in respect of the original licence which would apply to the NTS only in order to refer to the new licence condition numbers and to confirm that their effect is limited to the NTS only with effect from the date of completion of hive down;
 - 1.2 certain licence conditions have been modified pursuant to the section 8AA and associated section 23 directions so as to state that where the holder of the licence owns one or more relevant gas transporters, the licences which are held by a single legal entity, references in such new conditions to "licensee" shall mean that legal entity. As with all licence conditions modified by the section 8AA direction and associated section 23 notice referred to at (g) above, the conditions have also been renumbered as a result of the restructuring of the licences. Accordingly, Transco has requested that certain of the existing LRIs (which have been issued pursuant to such licence conditions) be amended and restated in respect of the original licence (in respect of the NTS) such that they apply to the licensee as a legal entity as a whole and reference the renumbered conditions; and
 - 1.3 certain LRIs be granted to the four relevant wholly owned Transco subsidiary companies in respect of the IDN licences and to Transco in respect of the RDN licence.
- (m). Having carefully considered Transco's request, the Authority is minded to direct that the existing LRIs be treated in the manner contained in this direction.

NOW THE AUTHORITY HEREBY DIRECTS AS FOLLOWS:-

- Having regard to the Transco's request and having received Transco's written consent (for itself and on behalf of each of the four relevant wholly owned subsidiary companies) the Authority hereby directs that:-
 - a. the existing LRIs contained in Schedule 1 to this direction shall continue in full force and effect subject to the following modifications;

i. they shall only apply to the NTS and shall have no application in respect of either

the DNs to be retained by Transco and /or the DNs to be hived down and sold by

Transco or in respect of the additional licences; and

ii they shall be amended and restated and these amended and restated documents

shall be treated as the conformed and accurate versions of these LRIs for all

purposes.

In addition the LRIs contained in Schedule 1 to this direction which are not existing

LRIs shall be issued for the first time in respect of the original licence (relating to the

NTS);

b. the LRIs contained in Schedule 2 to this direction shall be granted in respect of the

additional licences (in respect of the RDNs and IDNs);

c. the existing LRIs contained in Schedule 3 to this direction shall be reissued or issued

for the first time in respect of Transco as a legal entity; and

d. all other existing LRIs granted by the Authority on whatever basis and in whatever

form, and regardless of the terms of the LRI are, with the written consent of Transco,

revoked with the exception of those set out in Schedule 4 to this direction.

2. This direction shall take effect on and from the date of this direction and shall continue in

full force and effect unless varied by the Authority in writing following consultation with

Transco and/or holders of each of the five additional licences (as appropriate).
