



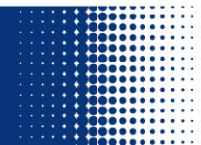

## ❖ INFORMATION THAT WOULD BE RELEASED

- Total Physical Flows for the previous gas day
- Published at D+1 12.00PM
- For all Exit Points from the NTS
  - Individual LDZ offtake from the NTS
  - Individual NTS connected storage site
  - Individual NTS connected power station
  - Individual NTS connected interconnectors
  - Individual NTS connected industrial load
- Total Shrinkage Volumes for the NTS for the previous gas day, disaggregated into Own Use Gas and Unaccounted for Gas
- Published on National Grid's public website

## ❖ EXIT POINTS IMPACTED

- 122 LDZ offtakes from the NTS
- 38 Power Stations (33 according to National Grid)
- 17 Industrial Sites
- 10 Storage sites (9 according to National Grid)
- 2 Interconnectors

## ❖ TIMING OF PUBLICATION

- Data to be published after the gas day at 12.00PM
- Data to be updated up to D+5 as additional information becomes available
- No requirement to publish data if it is not available to National Grid

## ❖ INTERACTION WITH EXIT REFORM PROPOSAL

- Mod 121 would release total physical offtake from the NTS by exit point at D+1 12.00PM stage – not flows up to 22.00.
- In Business Rules accompanying Mod 116 National Grid publish information:
  - By NTS Exit Point on volume of flat capacity allocated:
    - 24 hours after long term prevailing allocation,
    - 24 hours after completion of medium term auction
    - 1 hour after completion of day ahead firm auction
    - 1 hour after completion of day ahead interruptible auction
  - By NTS Exit zone the volume of flexibility capacity allocated.
