Monitoring company performance – quarterly reporting

Ofgem monitors the performance of domestic suppliers in relation to payment methods, debt and disconnections. Information is collected from suppliers on a quarterly and annual basis and the data received from suppliers is set out in tables and published on the Ofgem website.

For the reconnections table, suppliers will only be shown if they have disconnected customers in the relevant reporting period.

From April 2006, the company referred to as Telecom Plus in this report became a wholly owned subsidiary of Npower Ltd. From Q1 2007 this report will refer to the company as Gas Plus Supply Limited and Electricity Plus Supply Limited respectively. The accounts are managed and billed by arrangement with Telecom Plus plc, trading as the Utility Warehouse.
