

**Electricity Act 1989**

**Section 6**

**Notice of revocation of licence**

***Whereas***

- A. Npower Cogen Trading Limited (company registration number 02745602), having its registered office at Windmill Hill Business Park, Whitehill Way, Swindon, Wiltshire, SN5 6PB, is the holder of a Electricity Supply Licence (*the licence*) treated as granted under section 6(1)(d) of the Electricity Act 1989 (*the Act*).
- B. Section 6(8) of the Act provides that a licence granted or treated as granted under the Act may be revoked in accordance with any term contained in it. The terms of the licence provide that the Gas and Electricity Markets Authority (*the Authority*) may at any time revoke the licence on giving 30 days notice to Npower Cogen Trading Limited where it agrees in writing with the Authority that the licence should be revoked.
- C. By a letter dated 22 June 2007 Npower Cogen Trading Limited requested revocation of the licence. The Authority agrees the revocation shall take place.
- D. The Authority is satisfied that any arrangements required to be made in accordance with the terms of standard licence condition 10 of the electricity supply licence have been made.



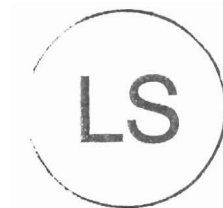

**NOTICE PURSUANT TO SECTION 49A(1)(a) ELECTRICITY ACT 1989**

**Reasons for the decision of the Gas and Electricity Markets Authority  
revoking the Licence treated as granted under Section 6(1)(d) Electricity  
Act to Npower Cogen Trading Limited**

The Gas and Electricity Markets Authority ("the Authority") was asked by Npower Cogen Trading Limited ("the Licensee") to revoke its Electricity Supply Licence ("the Licence") treated as granted under Section 6(1)(d) of the Electricity Act 1989.

**Decision**

The Authority will be revoking the Licence on 7 September 2007.

Notice of Revocation was issued to the Licensee on 7 August 2007.

**Reasons for Decision**

The Licensee requested in writing to the Authority that the Licence should be revoked in accordance with paragraph 1(a) of Schedule 2 of the Licence by letter dated 22 June 2007.
