

NOTICE UNDER SECTION 11(2) OF THE ELECTRICITY ACT 1989

The Gas and Electricity Markets Authority (the "Authority") hereby gives notice pursuant to section 11(2) of the Electricity Act 1989 (the "Act") as follows:

1. The Authority proposes to modify the individual conditions of each of the electricity distribution licences treated as granted under section 6(1)(c) of the Act (the "Licences") to each of the following electricity distributors:
 - a. Central Networks East Plc (Company Number 2366923)
 - b. Central Networks West Plc (Company Number 3600574)
 - c. EDF Energy Networks (EPN) Plc (Company Number 2366906)
 - d. EDF Energy Networks (LPN) Plc (Company Number 3929195)
 - e. EDF Energy Networks (SPN) Plc (Company Number 3043097)
 - f. Electricity North West Limited (Company Number 2366949)
 - g. Northern Electric Distribution Limited (Company Number 2906593)
 - h. Scottish Hydro Electric Power Distribution Plc (Company Number SC213460)
 - i. Southern Electric Power Distribution Plc (Company Number 4094290)
 - j. SP Distribution Limited (Company Number SC189125)
 - k. SP Manweb Plc (Company Number 2366937)
 - l. Western Power Distribution (South Wales) Plc (Company Number 2366985)
 - m. Western Power Distribution (South West) Plc (Company Number 2366894)
 - n. Yorkshire Electricity Distribution Plc (Company Number 4112320)
2. The Authority proposes to modify special condition A1 of the Licences in the manner contained in Schedule 1 to this Notice.
3. The effect of this proposed modification is to ensure that, when a proposed collective modification under section 11A of the Act to implement the Distribution Licence Review (the "DLR modification") takes effect, the special licence conditions of the Licences will retain their current meaning.
4. The reason for the proposed modification is that it is the intention of the DLR modification to amend the definitions of the standard licence conditions, not definitions of the special licence conditions. The amendment to special condition A1 ensures that the words and expressions contained within the special conditions are given the same meaning as provided by the definitions which were contained within the standard licence conditions prior to the proposed DLR modification taking effect.
5. Any representations or objections to the proposed licence modifications must be made in writing (preferably in electronic form for ease of publication on the Ofgem website) before **29 May 2008** to Nicholas Rubin, Office of Gas and Electricity Markets, 9 Millbank, London SW1P 3GE or by email to: distributionpolicy@ofgem.gov.uk, and if a respondent does not wish its response to be made public, the response should be clearly marked as not for publication.

Schedule 1

Paragraph 1 of special condition A1 shall be amended by the inclusion of the following underlined wording.

SPECIAL CONDITION A1 - Definitions and interpretation

1. Unless the context otherwise requires, words and expressions used in the standard conditions of this licence in the form which those conditions were in force at 31 May 2008 have the same meaning when used in the special conditions.
