

# Review of the market for exported electricity from microgeneration


In 2007 HM Treasury requested Ofgem to review the market for exported electricity from domestic-scale microgeneration

Review was published in March 2008. The key findings were:

- Suppliers are offering a range of fair value tariffs
- It is **complicated for customers** to work out the best deals because not all offers are directly comparable
- The economic payback on household microgeneration investments, which depend on several factors, may take 20 years or more; and
- Nonetheless, customers have responded to supplier's offers (1,500 households signed on)

The Government is thinking again about its preferred mechanism for microgeneration as part of the RES.

Household microgeneration could be improved by better provision of information to help customers find the best deals to suit their circumstances.



# Which has led to EST/OFGEM work

Announcement in 2008 Budget :

"The Energy Savings trust will also be working with Ofgem and energy suppliers to provide consumers access to easily comparable information on **export tariffs for microgeneration** through the Green Homes Service."

Yet to be decided how and what will be provided

Initial thoughts include: •Tables comparing tariffs •Links to suppliers websites •Fact sheets available from GHS •Personalised service from GHS to assist microgenerators in finding the best deal Important that stakeholders have input into this What information do you think would assist in comparing export tariffs ?
