## **SO** incentives for 1 April 2008

- National Grid led the consultation on and development of SO Incentive Initial Proposals
- National Grid have consulted on Initial Proposals for a back-dated methane incentive. Ofgem issued Final Proposals 3 July 2008

# **SO Incentives for 1 April 2009**

- National Grid leading Initial Proposals process
- Considering key issues for shallow incentives that expire 31<sup>st</sup> March 2009
- Earlier start to allow more time to review SO behaviours and to develop more innovative proposals



#### **Process Overview**

25 <sup>th</sup> June	Industry Workshop
July to Sept	'Mini' consultations on specific issues
Early Nov	Gas and Electricity SO Incentive Initial Proposals issued with consultation closing before Christmas
Jan	Consultation Report and recommendations issued
Jan onwards	Ofgem lead on development of final proposals, consultation and licence changes

## **Gas - Shrinkage**

- Should we have separate incentives for separate components of shrinkage?
- What is the right balance between target setting and procurement strategies?

# **Gas - Operating Margins**

- What are the different incentive structures and ways of unlocking potential additional value to the community?

## **Electricity Incentive development**

- Aim to address industry priorities
- Our belief is that these are:
  - Costs are minimised
  - Costs are predictable
  - Costs are transparent
  - Any other. . . . ?



#### **Electricity Incentive development priorities**

- Analyse drivers for increase in Transmission Losses
- Develop indexation methodology to drive incentive target
- Develop proposal for fixed price BSUoS
- Investigate constraint costs
- Consider benefits to a change in incentive year
- Any others . . . ?
