Decision letter: Gas and electricity licence Application Regulations and Guidance Document

On 5 August 2008 we published a consultation document¹ setting out proposed changes to the Gas and Electricity Application Regulations² and our Guidance Document³ on licence applications. The proposals were as a consequence of recent changes made to the gas transporter licence as part of the Gas Distribution Price Control Review ("GDPCR") and to the electricity distribution licence as part of the Distribution Licence Review ("DLR").

We received one response⁴ to the consultation. The respondent highlighted a typographical error in the Regulations and also suggested that paragraph 1.12 of the draft Guidance Document be amended to reflect the requirement for gas transporter and electricity distribution licence holders to publish in plain and intelligible language statements setting out their obligations under those licence conditions relating to vulnerable customers⁵. We have amended the Regulations in line with the respondent's suggestions.

The proposed changes have now been made. The existing Applications Regulations have been repealed and replaced by new Application Regulations⁶ which came into force today. Also, we have today published a final version of our Guidance Document on licence applications. The Guidance Document includes a link to the new Application Regulations.
