### What is the Qualifying Criteria?

Householders who:

- Live in one of the top 20% most deprived areas in National Grid's gas network area; and
- Spend more than 10% of their disposable income to heat their property to an adequate level of warmth; or
- Are in receipt of certain income related benefits; or.
- Are aged 70 or over.
