4. Lessons learnt and recommendations of any areas for change with the existing CoP's as a result of the audits completed.

- 4.1 The scope of activities captured by the current categories of work is too broad and does not reflect the variation both in terms of available work and competencies of the installers. This is eased to some extent in the CoP review as it has been aligned to the MAMCoP with the introduction of Category 2. The problem is addressed by approving an installer with restrictions. e.g. An installer may be registered to carry out CoP 1c work but is restricted to medium pressure installations up to G25/U40. In practice this would mean that should that company wish to provide additional services they would need to reapply. This is not an ideal situation and it may worth considering a small number of subcategories particularly for CoP1c/Category 4 installations.
- 4.2 The existing audit spread sheets are under review. They include elements which are not necessary but there are areas that require more attention. There is also some repetition. The spreadsheets will be reviewed in line with the CoP update and a new audit plan will be produced.
- 5. A report for the MAMCoP board to share experiences, best practice and observations from audits that may impact upon the MAMCoP, and recommendations and comments with regards to MAMCoP scope, content, structure and application.
- 5.1 Some evidence has been seen of poor installation standards and questionable design practices. For example more than one installer has advised us that a MAM will not pay for meter bracket and supplies them with small concrete blocks to stand the meter on.
- 5.3 Concerns have been raised by one installer over the standard of training that is being provided and questioned how training establishments are approved.
- 5.4 There is evidence of new primary meters that have been installed that are red in colour. Red has traditionally been the colour used to distinguish sub-meters from primary meters. The use of this colour does introduce a risk of confusion. What colour should primary meter be?

6. CoP's Review Progress Report.

6.1 The draft has been reviewed to ensure that all comments have been accounted for. This new draft will then need to be submitted for industry comment.
