# Ofgem's report on the first quarter of the Community Energy Saving Programme (CESP) 2009 - 2012

This letter fulfils Ofgem's reporting duties¹ to the Secretary of State for Energy and Climate Change under the Electricity and Gas (Community Energy Saving Programme) Order 2009 (the Order). It covers the operation of the CESP for the period 1 October 2009 to 31 December 2009, the first three months of the programme. By 31 December 2009 Ofgem had received only one CESP scheme notification, from an energy supplier, and there was no reporting against this scheme notification. There is, hence, in this first CESP annual report no activity achieved to report on.

Given the lack of activity, we have provided below an update on our work setting up the administration of the CESP programme, that enabled the obligated parties to start their CESP activity.

## Activity in the first quarter of CESP

# **Target Setting**

In September 2009, 13 electricity suppliers and 12 gas suppliers, under the big six supplier groups, and 39 generators under ten generation groups, were set a carbon emissions reduction obligation under CESP. The suppliers' obligations were set according to the number of domestic customers on their licences on 31 December 2008. Each generator's obligation was set based on the amount of electricity generated in 2008. A list of obligated parties is shown in Appendix 1.

#### <u>Administration</u>

In the first quarter of CESP, we published on time our CESP Generator and Supplier Guidance document which set out how we will carry out our functions as the administrator of the CESP. We also published administrative tools to assist the obligated parties in their CESP activity. These tools and the guidance document were developed in consultation with the industry and their timely publication ensured that the obligated parties could begin activity during the 2009/10 winter.

#### Forward look

Over the coming year, Ofgem will continue to work with the obligated parties on their CESP activity and their initial proposals and on ensuring that they comply with the CESP Order. By the end of March we had received 19 scheme notifications from four suppliers and one generator.

We will continue to work on the compliance reporting requirements and to put in place the IT systems to ensure the accurate monitoring of the obligated parties' completed activity. We will also put in place the reporting mechanisms to prevent and detect double counting between CESP and the Carbon Emissions Reduction Target 2008-2011.

Throughout the duration of CESP, Ofgem will monitor activity and publish data in a newsletter every six months. We will also report to you, in May 2011, on the progress that the obligated parties have made during first full year of CESP. By that time, we expect CESP activity to be fully underway and the obligated parties to have achieved a share of their CESP obligations.
