It is made clear that modifications to the EDCM and CDCM must be handled in accordance with Part D of SLC22A. Therefore, the veto process for charging methodologies currently provided for in the DCUSA will have to be removed.
SLC22A.17	Addition of new paragraph containing transitional provisions	Transitional provision to ensure validity of any proposed modifications to the CDCM that are reported to the Authority under the current veto process but the veto period has not expired before these proposed licence modifications, if approved, come into effect.
