

**Section 7A Gas Act 1986**

**Notice of revocation of Gas shipper licence**

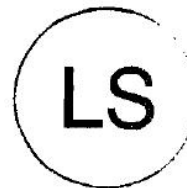
***Whereas***

- A. Caboodle Energy Limited (company registration number 05159846) having its registered office at 5 Windsor Court, Clarence Drive, Harrogate, HG1 2PE, Great Britain is the holder of a licence (*the licence*) treated as granted under section 7A(2) of the Gas Act 1986 (*the Act*) to it on 12<sup>th</sup> February 2007.
- B. Section 7B(3) of the Act provides that a licence granted or treated as granted under the Act may be revoked in accordance with any term contained in it. Paragraph 1(e)(ii) and 1(f)(v) of Schedule 2 of the Licence provides that the Gas and Electricity Markets Authority ("the Authority"), may at any time revoke the licence on giving 30 days' notice to Caboodle Energy Limited; where it has not commenced business as a gas shipper within a period of 3 years from the date on which the licence came into effect or where the licensee is subject to a winding-up order.
- C. By a letter dated 9<sup>th</sup> September 2010 the Authority confirmed to Caboodle Energy Limited, that having failed to provide satisfactory evidence that the licensable activity would commence the licence would be revoked.

***Notice of Revocation***

The Authority hereby gives notice that with effect from 10<sup>th</sup> November 2010 the licence shall be revoked.

**NOTICE PURSUANT TO SECTION 38A(1)(a) OF THE GAS ACT 1986**

**Reasons for the decision of the Gas and Electricity Markets Authority  
revoking the Gas Shipper Licence treated as granted under section 7A(2)  
of the Gas Act 1986 to Caboodle Energy Limited**

The Gas and Electricity Markets Authority ("the Authority") will revoke the Gas Shipper Licence held by Caboodle Energy Limited ("the Licence") treated as granted on 12<sup>th</sup> February 2007 under section 7A(2) of the Gas Act 1986.

**Decision**

The Authority will revoke the Licence on 10<sup>th</sup> November 2010.

Notice of Revocation was issued to the Licensee on 8<sup>th</sup> October 2010.

**Reasons for Decision**

In accordance with paragraph 1(e)(ii) of Schedule 2 of the Licence, the licensee has not commenced business as a gas shipper within a period of 3 years from the date on which the Licence came into effect. But also in accordance with paragraph 1(f)(v) of Schedule 2 of the Licence, the licensee is subject to a winding-up order.
