

**Section 7A Gas Act 1986**

**Notice of revocation of Gas shipper licence**

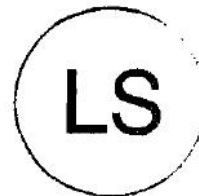
***Whereas***

- A. Vitol Gas Limited (company registration number 05066574) having its registered office at Belgrave House, 76 Buckingham Palace Road, London, SW1W 9TQ, Great Britain is the holder of a licence (*the licence*) treated as granted under section 7A(2) of the Gas Act 1986 (*the Act*) to it on 6<sup>th</sup> June 2004.
- B. Section 7B(3) of the Act provides that a licence granted or treated as granted under the Act may be revoked in accordance with any term contained in it. Paragraph 1(e)(ii) of Schedule 2 of the Licence provides that the Gas and Electricity Markets Authority ("the Authority"), may at any time revoke the licence on giving 30 days' notice to Vitol Gas Limited; where it has not commenced business as a gas shipper within a period of 3 years from the date on which the licence came into effect.
- C. By a letter dated 30<sup>th</sup> September 2010 the Authority confirmed to Vitol Gas Limited, that having failed to provide satisfactory evidence that the licensable activity would commence the licence would be revoked.

***Notice of Revocation***

The Authority hereby gives notice that with effect from 22<sup>nd</sup> November 2010 the licence shall be revoked.

**NOTICE PURSUANT TO SECTION 38A(1)(a) OF THE GAS ACT 1986**

**Reasons for the decision of the Gas and Electricity Markets Authority  
revoking the Gas Shipper Licence treated as granted under section 7A(2)  
of the Gas Act 1986 to Vitol Gas Limited**

The Gas and Electricity Markets Authority ("the Authority") will revoke the Gas Shipper Licence held by Vitol Gas Limited ("the Licence") treated as granted on 8<sup>th</sup> June 2004 under section 7A(2) of the Gas Act 1986.

**Decision**

The Authority will revoke the Licence on 22<sup>nd</sup> November 2010.

Notice of Revocation was issued to the Licensee on 19<sup>th</sup> October 2010.

**Reasons for Decision**

In accordance with paragraph 1(e)(ii) of Schedule 2 of the Licence, the licensee has not commenced business as a gas shipper within a period of 3 years from the date on which the Licence came into effect.
