

**Section 7A Gas Act 1986**

**Notice of revocation of Gas shipper licence**

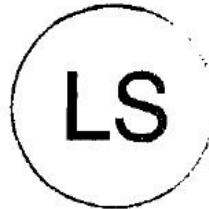
***Whereas***

- A. Ineos Chlor Energy Limited (company registration number 02076043) having its registered office at PO Box 9, Runcorn Site HQ, South Parade Runcorn, Cheshire, WA7 4JE, Great Britain is the holder of a gas shipper licence (*the licence*) treated as granted under section 7A(2) of the Gas Act 1986 (*the Act*) to it on 17<sup>th</sup> October 2005.
- B. Section 7B(3) of the Act provides that a licence granted or treated as granted under the Act may be revoked in accordance with any term contained in it. Paragraph 1(e)(i) of Schedule 2 of the Licence provides that the Gas and Electricity Markets Authority ("the Authority"), may at any time revoke the licence on giving 30 days' notice to Ineos Chlor Energy Limited; where it has ceased business as a gas shipper for a period of 3 years.
- C. By a letter dated 25<sup>th</sup> October 2010 the Authority confirmed to Ineos Chlor Energy Limited, that having failed to provide satisfactory evidence that the licensable activity would commence the licence would be revoked.

***Notice of Revocation***

The Authority hereby gives notice that with effect from 13<sup>th</sup> December 2010 the licence shall be revoked.

**NOTICE PURSUANT TO SECTION 38A(1)(a) OF THE GAS ACT 1986**

**Reasons for the decision of the Gas and Electricity Markets Authority  
revoking the Gas Shipper Licence treated as granted under section 7A(2)  
of the Gas Act 1986 to Ineos Chlor Energy Limited**

The Gas and Electricity Markets Authority ("the Authority") will revoke the Gas Shipper Licence held by Ineos Chlor Energy Limited ("the Licence") treated as granted on 17<sup>th</sup> October 2005 under section 7A(2) of the Gas Act 1986.

**Decision**

The Authority will revoke the Licence on 13<sup>th</sup> December 2010.

Notice of Revocation was issued to the Licensee on 9<sup>th</sup> November 2010.

**Reasons for Decision**

In accordance with paragraph 1(e)(i) of Schedule 2 of the Licence, the licensee has ceased business as a gas shipper for a period of 3 years.
