NOTICE OF PROPOSED MODIFICATIONS OF THE STANDARD LICENCE CONDITIONS OF:

- THE ELECTRICITY SUPPLY LICENCE UNDER SECTION 11A OF THE ELECTRICITY ACT 1989, AND
- THE GAS SUPPLY LICENCE UNDER SECTION 23 OF THE GAS ACT 1986

On 10 August 2010, the Gas and Electricity Markets Authority (the "Authority") consulted under section 11A of the Electricity Act 1989 and section 23 of the Gas Act 1986 on a proposed modification *Standard Licence Condition 21A 'Provision of the annual statement of supply to participants of the CRC Energy Efficiency Scheme'*. At the same time the Authority also consulted on a guidance document to the proposed modification.

The consultation closed on 21 September 2010. We received several responses to the consultation about the draft guidance accompanying the proposed modification. Following further clarification of these issues, including from the Department of Energy and Climate Change, we have decided not to proceed with the modification but instead to amend the guidance notes and consult again on the modification proposal.

Today we are opening a new consultation on the proposed modification (which is not materially changed) and at the same time issuing revised guidance to clarify the requirements of the proposed modification as set out by Section 63 of the Order. While opening another consultation delays the insertion of the licence condition we think it is warranted for clarity and transparency and to make certain suppliers are fully aware of their legal obligations under the proposal.

For the reasons set out in this letter and in accordance with section 11A of the Electricity Act and section 23 of the Gas, Act the Authority is proceeding with a fresh statutory consultation on the proposed insertion of a new standard licence condition to the standard conditions of electricity and gas supply licences.

Proposed modification

Subject to consideration of any representations or objections to the notices of proposed modifications the Authority proposes to modify the standard conditions of the electricity and gas licences as per accompanying notices by:

a) Inserting new Standard Licence Condition 21A ('Provision of the annual statement of supply to participants of the CRC Energy Efficiency Scheme') to the standard conditions of electricity supply licence

b) Inserting new standard condition 21A ('Provision of the annual statement of supply to participants of the CRC Energy Efficiency Scheme') to the standard conditions of gas supply licence

The proposed standard licence conditions for electricity and gas suppliers are set out in the schedules of the relevant notices. Alongside this letter, we are also publishing revised guidance notes on the requirements of the proposed modification.

Reasons for the proposed modifications

The Carbon Reduction Commitment Energy Efficiency Scheme (CRC) was introduced in April 2010. It is a new mandatory scheme to improve energy efficiency in large public and private sector organisations. The Environment Agency administers the CRC on behalf of the Department for Energy and Climate Change and the Welsh Ministers, and the Scottish Environment Protection Agency (SEPA) on behalf of the Scottish Ministers¹.

The "CRC Energy Efficiency Scheme Order 2010"² (CRC Order) came into effect on 1st April 2010. The CRC Order places requirements on licensed energy suppliers to provide an annual statement of supply to participants of the CRC scheme covering the year from 1 April to 31 March.

The Government decided this requirement on licensed energy suppliers should be a condition in the gas and electricity supply licences, and that enforcement of this obligation should be by the Gas and Electricity Markets Authority in accordance with its powers under sections 28 to 30F of the Gas Act 1986 and sections 25 to 28 of the Electricity Act 1989.

Next steps

Although any person may make representations, only those licensees who are "relevant licence holders" under paragraph section 11A(10) of the Electricity Act 1989 and under paragraph section 23(12) of the Gas Act 1986 may register a formal objection to any proposed modification.

All responses will normally be published on Ofgem's website and retained in the Ofgem Research and Information Centre. However, if respondents do not wish their response to be made public then they should clearly mark their response as confidential.

³ Relevant licensees are able to lodge objections against any proposed licence modification. The level of objections will be measured against a blocking-minority threshold of 20 per cent that was prescribed by the Secretary of State in an Order dated 15 July 2003. The Order states that:

if the number of relevant licence holders that object to a collective licence modification proposal is equal to or greater than 20 per cent of the total number of relevant licence holders, or

if the market share of objectors is equal to or exceeds 20 per cent,

the proposed modification may not be made (except via the Competition Commission).
