Notice of revocation of licence


Whereas

- A. Affinity Power Limited (company registration number 04498201) having its registered office at 5 Deneshey Road, Meols, Wirral, Merseyside, CH47 3AA, Great Britain is the holder of an electricity supply licence (*the licence*) treated as granted under section 6(1)(d) of the Electricity Act 1989 (*the Act*) to it on 27th September 2002.
- B. Section 6(8) of the Act provides that a licence granted or treated as granted under the Act may be revoked in accordance with any term contained in it. Paragraph 1(e)(i) of Schedule 2 of the Licence provides that the Gas and Electricity Markets Authority ("the Authority"), may at any time revoke the licence on giving 30 days' notice to Affinity Power Limited; where it has not commenced business as an electricity supplier within a period of 5 years from the date on which the licence came into effect.
- C. By a letter dated 24th November 2010 the Authority confirmed to Affinity Power Limited, that having failed to provide satisfactory evidence that the licensable activity would commence the licence would be revoked.
- D. The Authority is satisfied that any arrangements required to be made in accordance with the terms of standard licence condition 10 of the electricity supply licence have been made.

NOTICE PURSUANT TO SECTION 49A(1)(a) ELECTRICITY ACT 1989
