Consultation on Horizon Nuclear Power Wylfa's request for consent from the Authority to exercise its exploratory rights under the Electricity Act 1989 (closing date 23 November).

Purpose of this letter

Ofgem has received an application from Horizon Nuclear Power Wylfa for consent to exercise their exploratory rights under the Electricity Act 1989 and SLC 15. As part of our decision making process we would like to invite interested parties to provide us with their views on this request for consent. This consultation will be open for seven days (or five working days).

Background

A generator's rights to access a third party's land for exploration purposes are described in schedule 4, paragraph 10 of the Electricity Act 1989 and Standard Licence Condition 15 of the Standard Conditions of the Electricity Generation Licence.

The Electricity Act allows a generation licence holder to enter and survey any land to establish whether it would be suitable for the construction/extension of an electricity generation station. Under the Act, there are a number of statutory obligations which the licence holder must honour if it exercises this power.

These powers are further restricted by Standard Electricity Generation Licence Condition 15. This Condition requires the Licence Holder to receive the consent of the Authority¹ before it can exercise its powers to enter land under the Electricity Act.

The right to enter the land in question is therefore granted to the licence holder by the Electricity Act rather than the Authority. Our role is to ensure that the access is in relation to the construction or extension of a generation station.

As mentioned above, on 04 November, Ofgem received an application from Horizon Nuclear Power Wylfa for consent to exercise their exploratory rights under the Electricity Act 1989 and SLC 15. As part of our decision making process we would like to invite interested

parties to provide us with their views on this request for consent. This consultation will be open for seven days (five working days).

Documents

For the reference of interested parties we have made available the relevant sections of the Electricity Act, the Electricity Generation Licence and Horizon's application letter requesting consent. These will also be available on the Ofgem website.

Please note that paragraphs 15 and 16 as well as Schedules 1 and 2 of Horizon's application have been redacted as these contain personal and commercially sensitive information.

Interested parties are invited to write to us outlining any issues that should be considered in assessing Horizon's application under Standard Licence Condition 15.
