

# Climate Change Levy Exemption for Good-Quality Combined Heat and Power Certificate (CHP LEC) Schedule 2012/2013

**Version number:** 1

**Issue Date:** April 2012

**Column A** sets out the date by which Ofgem must receive electricity production figures for Climate Change Levy exemption for good-quality CHP purposes. If any operator experiences difficulty submitting such data to Ofgem within the timeframes in this schedule, we should be notified **before** the relevant date in column A\*.

If data is submitted to Ofgem after the date shown in column A in respect of the corresponding month of generation, CHP LECs will not be issued within the normal monthly CHP LEC issue. It may be possible to consider the output as part of the annual reconciliation process, which takes place after 1 July annually.
