Certification under the ownership unbundling requirements of the Third Package¹
Decision of the Gas and Electricity Markets Authority ('the Authority')

The Electricity and Gas (Internal Markets) Regulations 2011 ('the GB Regulations') require transmission system operators ('TSOs') to be certified as complying with the ownership unbundling requirements of the Third Package.

Current and future transmission and interconnector licensees² are required to apply for certification under the ownership unbundling requirements of the Third Package pursuant to the GB Regulations. The certification procedures are set out in the Electricity Act 1989 ('the Electricity Act') and in the Gas Act 1986 ('the Gas Act') as amended by the GB Regulations.

On 11 November 2011 Ofgem³ published an open letter setting out information on our intended procedure for processing applications for certification under the ownership unbundling requirements of the Third Package.

Blue Transmission Walney 2 Limited ('Walney 2'), Blue Transmission Sheringham Shoal Limited ('Sheringham Shoal ') and Blue Transmission London Array Limited ('London Array') submitted separate applications under section 10B(2) of the Electricity Act requesting to be certified pursuant to the ownership unbundling requirements (as set out in Article 9(1) of the Electricity Directive⁴ and transposed into GB law by section 10F of the Electricity Act).

This letter sets out Ofgem's final decision on Walney 2, Sheringham Shaol and London Array's applications for certification under section 10D of the Electricity Act.

Background

The Third Package is a suite of legally binding European Union legislation. The Third Package imposes new obligations on certain industry participants.

The GB Regulations have amended relevant domestic legislation, including the Gas Act, the Electricity Act and the Utilities Act 2000.

The GB Regulations have designated the Authority as the National Regulatory Authority for GB and have given it the responsibility for administering the certification process for current and future GB electricity transmission, gas transportation and electricity and gas interconnector licensees.

Application for certification

Of the three applicants, Sheringham Shoal and London Array are expected to become licensed offshore transmission system operators (OFTOs)⁵ in 2013 under section 6(1)(b) of the Electricity Act. Walney 2 is currently an OFTO licensee.

Walney 2 and London Array are ultimately owned and controlled by the same persons, are part of the same corporate group and have the same sole business focus. They are a joint venture between an investment fund managed by Barclays plc, namely Barclays Integrated Infrastructure Fund ('BIIF'), and Mitsubishi Corporation ('Mitsubishi'). Sheringham Shoal is expected to be owned and controlled by the same joint venture when it starts operating as an OFTO. In addition, the three applicants all have the same sole business focus of transmission of offshore wind energy. The circumstances relevant to the Authority's assessments of each of their certification applications are essentially the same and as such,

it was considered appropriate to assess and determine their applications collectively. In this letter Walney 2, Sheringham Shoal and London Array will be referred to as 'the Applicants'.

The Applicants had requested certification on the first certification ground, which is set out in section 10E(3) of the Electricity Act. The first certification ground is that an applicant meets the ownership unbundling requirement in section 10F of the Electricity Act.

The Authority is required to apply five tests in order to determine whether each of the Applicants meets the ownership unbundling requirement:

The first test is that the applicant—

- (a) does not control a relevant producer or supplier;
- (b) does not have a majority shareholding in a relevant producer or supplier; and
- (c) will not, on or after the relevant date, exercise shareholder rights in relation to a relevant producer or supplier.

The second test is that, where the applicant is a company, partnership or other business, none of its senior officers has been, or may be, appointed by a person who—

- (a) controls an electricity undertaking which is a relevant producer or supplier; or
- (b) has a majority shareholding in an electricity undertaking which is a relevant producer or supplier.

The third test is that, where the applicant is a company, partnership or other business, none of its senior officers is also a senior officer of an electricity undertaking which is a relevant producer or supplier.

The fourth test is that the applicant is not controlled by a person who controls a relevant producer or supplier.

The fifth test is that the applicant is not controlled by a person who has a majority shareholding in a relevant producer or supplier.

On the basis of the information contained in the applications, the Authority considered that each of the five tests set out in section 10F of the Electricity Act was met by each of the Applicants.

The Authority made its preliminary decisions under section 10D(1) of the Electricity Act on 7 Feburary 2013 on the applications by the Applicants and decided that each should be certified as independent. The Authority's preliminary decisions were notified to the

European Commission ('the Commission') in accordance with section 10D(4) of the

Electricity Act.

The Authority received the Commission's opinion on 5 April 2013. In accordance with Article

3(2) of the Electricity Regulation⁶, the Authority has taken utmost account of that opinion in

reaching its final decision which is set out below.

The Authority's final decision is that as of and from the date of this decision, each of the

Applicants should be certified as independent on the basis that each of the five tests set out

in section 10F of the Electricity Act is met by each of the applicants.

In accordance with section 10H(2) of the Electricity Act, Walney 2, being an OFTO licence

holder pursuant to section 10H(1) of the Electricity Act and certified on the first certification

ground, is designated as an electricity transmission system operator for the purposes of

Article 10(2) of the Electricity Directive. A separate notification regarding designation will

be made in respect of Sheringham Shoal and London Array on grant of an offshore

transmission licence.

In accordance with section 10D(7) of the Electricity Act, the Authority hereby notifies the

certification of the Applicants to the European Commission and the Secretary of State. In

accordance with section 10H(4) of the Electricity Act, the Authority hereby notifies the

designation of Walney 2, to the European Commission and the Secretary of State.

In accordance with section 10I of the Electricity Act, the Authority will monitor whether the

basis on which it decided to certify the Applicants continues to apply following the

Authority's final decisions and if appropriate, will review its certification decisions.

Attached to this letter are copies of the certification decisions granted by the Authority.

 - s. the certified person has a receiver (which expression shall include an administrative receiver within the meaning of section 251 of the Insolvency Act 1986, as amended from time to time) of the whole or any material part of its assets or undertaking appointed;
 - t. the certified person has entered into administration under section 8 of Schedule B1 to the Insolvency Act 1986;
 - u. the certified person is found to be in breach of any national or European competition laws, such breach relating to the licensed activity of the certified person;
 - v. the certified person has failed to provide a declaration to the Authority pursuant to paragraph C5 above and the Authority has written to certified

- person stating that the declaration has not been provided and giving the certified person notice that if the declaration remains outstanding past the period specified in the notice the certification may be withdrawn;
- w. the certified person has failed to comply with a request for information issued by the Authority under paragraph C6 above and the Authority has written to the certified person stating that the request has not been complied with and giving the certified person notice that if the request for information remains outstanding past the period specified in the notice the certification may be withdrawn; or
- x. to ensure compliance with any legally binding decision of the Agency or of the Commission.
- 6. This certification may be withdrawn if the certified person notifies the Authority that it does not require to be certified and the Authority considers that the certified person is not a person who is required to be certified.
