REMIT Messages

The REMIT regulation places an obligation on energy market participants to publish information relating to wholesale energy products which would be likely to significantly affect the price of those products.

REMIT creates an EU-wide legal framework to prevent market abuse and reinforce the transparency and integrity of wholesale energy markets.

If you become aware of an error in an already published message, you can only correct it by sending a new message replacing the wrong one.
