# **Barriers to growth**

- Most CEOs are small and volunteer-led
- Lack business skills, legal knowledge & funding
- Big 6 /DNOs/LAs not encouraging development
- National and local policy framework
- Planning and regulatory process/restrictions
- Markets not designed for small projects
- Lack of incentives for CEOs involved in renewable heat; reduction and management

# RESULT: UK community energy = 0.3% of all renewables v 46% in Germany

## How OFGEM can help CEOs

- Encourage energy suppliers and DNOs to partner/provide development funding for leading CEOs
- Renew funding for community engagement projects with DNOs
- Reduce regulatory/ administrative burden
- Amend ECO: still 'stop –start' with most going to affluent
- Recommence demand reduction /management trials
- Reduce grid connection and transmission costs
- Review grid connection rights
- Review License Lite to accommodate needs of CEOs
- Regulate developers of community heating schemes
- Encourage DECC to change regulations re RHI /Big Lottery funding
- Refer consumers to local CEOs, not just EST
