

**Feed-in Tariff Payment Rate Table for Non-Photovoltaic Eligible Installations for FIT Year 5 (1 April 2014 to 31 March 2015)**

The FIT tariff rate for an Accredited FIT Installation of a description specified in the first column of the tables below and with a Tariff Date specified in the second column is the applicable rate specified in the corresponding entry in the third column.

**All tariffs have been adjusted by the annual RPI rate (as at December 2013) of 2.7 percent.** In addition, a number of post 1 April 2014 tariffs have been degressed in line with the conditions of the FIT Legislation.

Under certain circumstances, further degression may occur on 1 October 2014. If this occurs, new tariffs from 1 October 2014 will be republished by 31 July 2014.

All tariff rates are specified as pence per kilowatt hour at 2014/15 values.
