Regulatory instructions and guidance described by Amended Standard Condition E12 – D1 of the TR1 offshore transmission licence

We have today directed changes to the TR1 RIGs. The modifying Direction and the updated TR1 RIGs are published alongside this letter. The effective date for the modifications to the RIGs is 01 April 2014.

The updated RIGs include minor amendments to make them easier for the Licensees to complete. We have also included an amendment to provide us with a breakdown of debt interest costs in the statement of comprehensive income and Cash flow sheets. Details of these modifications are contained in the Appendix.
