## Proposal to modify the electricity supply licence Standard Licence Conditions (SLCs) by inserting a new condition, SLC 21D

EDF Energy welcomes the opportunity to makes representations on the proposed new standard supply licence condition 21D following the publication of the statutory consultation on 1 October.

EDF Energy fully supports Ofgem's proposal to introduce licence conditions that regulate all tariffs that make environmental claims based on the supply of renewable electricity for the domestic market. In terms of the proposed licence condition, we do not have any substantive comments but would like to raise the following points in terms of the detailed wording:

- The sub-paragraph numbering in 21D.2, 21.D4 and 21D.8 is incorrect
- In 21D.8 reference is made to "Fuel Mix Disclosure", however, this term is not currently defined in the licence or included as a defined term within SLC21D
- In 21D.9 "environmental claim" is a defined term and should therefore be in a capitalised form
- In 21D.10 the brackets need to be removed at the end of the paragraph
- In 21D.11 reference to paragraph 6 should be reference to paragraph 21D.6
