Yes, we have summarised our thoughts below:

- Better access for UIPs and iGTs to the scheme, i.e. opened up to competition to drive down costs, improve speed of delivery and delivering other services in a truly coordinated way (central heating, broadband, other utilities)
- Review of the voucher scheme and the timescales for drawing down the funds –
 this is currently a barrier to entry for independents who could offer a better, more
 competitive service
- We have experienced issues in areas with a mix of fuel poor and privately owned properties who are not 'fuel poor' but required their sign on to make projects feasible. In our experience, there is little incentive for them to do this and make the overall project viable – should an incentive for non fuel poor properties in fuel poor areas be available to enable wider schemes to happen
- There is a lack of visibility on how the GDNs select a UIP to deliver the works on their behalf, with many appearing to be 'closed shops'. How can the GDNs confirm that they are obtaining best value from their incumbent providers?
- Better accessibility to information on specific fuel poor households would enable engagement to be proactively driven by utility providers, rather than responsive to requests from housing associations / local authorities

Q7 Do you agree with the updates to the eligibility criteria suggested in Annex 1? If not, please explain your rationale and any other changes you would like to see?

Yes, however access to this information should be made readily available to enable providers to target individual homeowners and areas.

Q8 Do you agree with this change to the average domestic gas consumption value?

Yes, this is correct for new build properties. However, has this been tested against pre 1977 buildings?
