Statutory consultation on adding new National Transmission System exit points to National Grid Gas Transmission's gas transporter licence and on the categorisation of exit points

On 11 November, we¹ published a section 23 notice of modification to Part G of Special Condition 5G of National Grid Gas Transmission's (NGGT's) gas transporter licence. The modification would add three new exit points to its gas transporter licence. We are also proposing correcting "Theddlesthorpe" to "Theddlethorpe" and changing "Kintore" to "Glasgoforest".

EU Gas Regulation² requires us to decide whether any new exit points should be classified as relevant points. For relevant points, NGGT is required to make information about capacity available to the public. We agree with NGGT's proposal that the new exit points Apache (Sage Black Start) and Trafford Power Station should not be classified as relevant points. Seal Sands TGPP³ should be classified as a relevant point as it may not be connected to a single final customer.

Further, we agree with NGGT's proposal that another exit point, Kintore (to be renamed Glasgoforest) should not be classified as a relevant point. This point has already been included in NGGT's gas transporter licence.

This letter explains the background to the proposed modification.

Changes to the licence

Table 8 in Special Condition 5G, Part G, lists all National Transmission System (NTS) exit points where exit capacity can be bought by shippers. NTS exit points must be listed in this table to allow NGGT to make exit capacity available to NTS users.

On 9 July 2014 NGGT requested that we add three new exit points, shown below, to this table.

NGGT is not requesting a revenue driver at present for any of these new exit points. We propose that these three exit points should be added to the licence. The new draft text can be found in Appendix 1 to the section 23 notice.

We are also proposing correcting the spelling of the exit point "Saltfleetby Storage (Theddlethorpe)", which is misspelt in the current text. NGGT has requested changing the name of the exit point "Kintore" to "Glasgoforest". These amendments are shown in the text of the proposed licence modification.

Other proposed changes to the licence

Respondents should note that we are currently consulting on other changes to Special Condition 5G of NGGT's licence, to facilitate the implementation of Planning and Advanced Reservation of Capacity Agreements (PARCAs).⁵ There is no direct policy interaction between the changes proposed in this consultation and the proposals designed to facilitate PARCAs. The final text following the conclusion of both consultations will have changes to implement PARCAs which are not shown in the draft attached to this letter.

Classification of relevant points

When we add new exit points to the licence, we must, in accordance with Article 18.3 of the EU Gas Regulation, consider if they are 'relevant points'.⁶ This Regulation requires Transmission System Operators (TSO) to make information on the technical, contracted and available capacities at all relevant points available to the public on a regular basis. Points which are connected to a single final customer are exempt from this obligation, as publishing the information outlined above could have commercial confidentiality impacts. The TSO will publish aggregated information for points which fall outside the definition of the relevant point.

Kintore/Glasgoforest

The exit point at Kintore (to be renamed Glasgoforest) was added to NGGT's transportation licence in April 2013. We agree with NGGT that it should not be considered as a relevant point as it is connected to a single final consumer. NGGT have said it should be listed as an Industrial Offtake.

Apache (Sage Black Start) and Trafford Power Station

We agree that Apache (Sage Black Start) and Trafford Power Station should not be considered relevant points, as NGGT have said they are connected to a single final customer. NGGT have said that Apache (Sage Black Start) should be listed as an Industrial Offtake and Trafford Power Station should be listed as a Power Station. Not defining them as relevant points would be in line with previous treatment of DC offtake points.

Seal Sands TGPP

We think Seal Sands TGPP should be considered a relevant point. NGGT have said that Seal Sands will be defined as a Connected System Exit Point for the purposes of the Uniform Network Code. Once gas is delivered from the NTS to Seal Sands it may be transported downstream to other gas customers through an Independent Gas Transporter. In our view, this means that there may be more than one single final customer at Seal Sands TGPP.
