 Clarification that for the purposes of Rule 3.5, references to the Grid Connection Agreement, Distribution Connection Agreement or connection offer for a Generating Unit are to the agreement or offer in force at the date on which the Application is made. 	
 Clarification that for the purposes of Rule 3.5, if a Distribution Connection Agreement or connection offer states a range of values for the registered capacity or inverter rating of a Generating Unit, the registered capacity or inverter rating of the Generating Unit must be taken to be the lowest value in that range.". 	
 Consequential amendment to previous paragraph. In Rules 3.6.3(c)(ii)(aa) & 3.7.3(b)(ii)(aa) clarification that where a Distribution Connection Agreement specifies a range of values for the registered capacity or inverter rating, the minimum and maximum values in that range are to be confirmed. 	
 Clarification that for the purposes of Rule 3.5, references to Connection Entry Capacity, Registered Capacity or Inverter Rating are net of the generating unit's auxiliary load, as declared in their pre-qualification application. Please note, no proposed revised drafting is provided for this amendment.

1. After Rule 3.5.5 insert:	
"3.5.6, For the purposes of this Rule 3.5:	

- (a) references to the Grid Connection Agreement, Distribution Connection Agreement or connection offer for a Generating Unit are to the agreement or offer in force at the date on which the Application is made; and
- (b) if a Distribution Connection Agreement or connection offer states a range of values for the registered capacity or inverter rating of a Generating Unit, the registered capacity or inverter rating of the Generating Unit must be taken to be the lowest value in that range.".
- 2. In Rule 3.6.3, at the end of paragraph (c)(ii)(aa) insert ", or, if the Distribution Connection Agreement specifies a range of values for the registered capacity or inverter rating, the minimum and maximum values in that range".
- 3. In Rule 3.7.3, at the end of paragraph (b)(ii)(aa), insert ", or, if the Distribution Connection Agreement or connection offer specifies a range of values for the registered capacity or inverter rating, the minimum and maximum values in that range".
