- 1. The Authority proposes to issue the regulatory instructions and guidance ("RIGs") provided for under Standard Condition 46 of the electricity distribution licence held by each of the above licensees ("the licensees").
- 2. The proposed RIGs are available on our website. Scheduled 1 to this Notice provides links.
- 3. The reason why the Authority proposes to issue the RIGs is to provide it with information:
  - a) needed to administer:
    - i. the Charge Restriction Conditions (and such standard conditions as may be relevant) of the electricity distribution licence, and
    - ii. where not referenced in the Charge Restriction Conditions, the ED1 Final Determinations.  $^{\rm 1}$
  - b) that is consistent across the licensees so that it can be compared.
- 4. The Authority proposes to issue the RIGs in a direction on or after 22 May 2015 and the RIGs will take effect from 1 April 2015.
