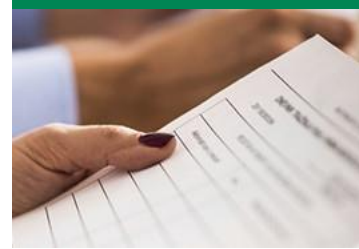


[DECC's Green Deal and ECO Monthly Statistical Release](#)

Loft insulation measures

We've also recently published a guidance note giving information on notifying, monitoring and calculating savings for loft insulation measures where pre-existing insulation has recently been removed.

This new guidance requires that scores calculated for these measures assume a pre-existing insulation level of 100mm. [Read more.](#)

ECO1 reporting update

Last month we [issued our final monthly compliance update for ECO1](#). This shows progress towards the ECO1 targets. We're currently working towards our final determination of suppliers' compliance against their obligations and will issue our final report at the end of September.
